- 29. At their own discretion, MYOB may provide sandboxes at no charge for support or EAP purposes. These sandboxes are to be used for their intended purposes only and will be removed by MYOB at the conclusion of that intended purpose.
- 30. Sandboxes have less system resources than production accounts and as such may not perform in the same manner and do not include any service level commitments.
- 31. Subscription charges for sandbox environments are not discountable.
- 32. The minimum period for an on-demand sandbox is 1 month.
