For the purposes of calculating charges, consumption is rounded up to the nearest chargeable level (e.g., If a service uses 25.2 GB of data but is only entitled to 20 GB of storage, then a charge of \$21.00 will be levied equivalent to an additional 10 GB of storage @\$21/10 GB).
- 7. Subscription charges for resources are not discountable and do not qualify for Partner Margins.
- 8. SMS Messaging must be used in the subscription month purchased. Any unused messaging is not rolled over. SMS Messaging is only available from release 2021.1.

- 1. Sandbox entitlements mirror those of the corresponding production account (users and resources). Exceeding resource (storage space, campaign emails, companies and customer portal accesses) entitlements at any time in a month will automatically incur over-usage charges.
- 2. Sandboxes are available for testing and training and are not permitted for the purposes of trading. Certain functions, such as but **not limited** to emailing, are disabled in sandbox systems.
- 3. At their own discretion, MYOB may provide sandboxes at no charge for support or EAP purposes. These sandboxes are to be used for their intended purposes only and will be removed by MYOB at the conclusion of that intended purpose.
- 4. Sandboxes have less system resources than production accounts and as such may not perform in the same manner and do not include any service level commitments.
- 5. Subscription charges for sandbox environments are not discountable.
- 6. The minimum period for an on-demand sandbox is 1 month.

General Notes

- Accounts may be upgraded to higher editions, but downgrades are not possible within the same account.
